#### **SCOPE AND CONTENT NOTE:**

This collection offers information about administrative activity and leadership on campus [that is an extension of the work of the President's office]. Sources include minutes and reports from committees, advisory councils, and task forces; general policies and procedures; and general correspondence from the offices of administrators who report to the President of the University. This collection is representative rather than comprehensive.

#### **SERIES DESCRIPTION:**

#### Series I – Administrative Staff

This series includes information on administrators at Eastern. It also offers staff directories and organizational charts which give insight into the structure of the staff as the college/university grew. This series is organized chronologically. Dates listed for individuals reflect their years of service to the university.

#### Series II – Correspondence

This series includes general correspondence concerning the administrative work of running the university and information concerning the development of the administrative structure following 1959 legislation to add a liberal arts degree program to the four state teacher's colleges. It also documents changes in the leadership structure as the student population and the campus grew.

#### Series III – Committees

This series contains documents and minutes from the Administrative Council, Administrative Assembly, Dean's Council/Committee, Advisory Council and other committees which met between 1964 and 1988. It also includes documents concerning later task force initiatives, and academic master plans.

#### Series IV - Policy & Procedure

This series includes policies and procedures created between 1931 and 1996. They include the first Alcohol Policy, Administrative organization, student rights & regulations, weather closings, It also offers copies of current policy and procedural statements distributed to the campus community.

#### Series V – Reports

This series includes final reports of major administrative initiatives including master plans and strategic plans.
