Human Resources, 1960-present University Archives Eastern Connecticut State University

SCOPE AND CONTENT NOTE:

This collection offers information on employment issues at Eastern dating from the mid-1960s to the present. Correspondence and policy documents offer information on specific issues such as workplace safety, contracts, state benefits and the rights and responsibilities of Eastern employees. The publications series includes some early news clippings, newsletters and some job descriptions from the 1980s and 1990s. Series IV includes information about the development and growth of collective bargaining and union activity on campus. It includes early correspondence, contracts & documentation, meeting minutes, reports and publications.

SERIES DESCRIPTION:

Series I – Correspondence

This series includes a variety of general correspondence related to employment contracts, benefits, hiring, and retirement plus flyers and notices offering information about workshops, educational meetings and special events offered to employees.

Series II – Policy & Procedures

This series offers copies of formal policies as well as general procedural guidelines and information. Items include hiring procedures, employee handbooks, brochures and statements on topics such as ethics and non-discrimination. Detailed contract information is available in a separate collection titled Unions and Collective Bargaining.

Series III – Publications

This series includes some articles published by the staff, news clippings, a collection of the *Human Resource* newsletter, employee ratios and salary analysis from the 1970s, job descriptions from the 1980s and 1990s and information from the departmental web pages.

Series IV – Unions & Collective Bargaining

This series is divided into 4 sub-series by union/collective bargaining unit and may include correspondence, contracts, chapter documents, reports and publications as follows:

Sub-series I – AAUP - American Association of University Professors Includes a broad range of information dating from 1959 to the present including correspondence, contracts, reports and a large collection of publications. Publications include: CSU-AAUP *Newsletter* (1976-present), ECSC-AAUP *Newsletter* (1977-1980), ECSU-AAUP *Union Rag* (1980-present), and the AAUP *Vanguard*, CT Conference (1980-present).

Sub-series II – AFSCME - American Federation of County, School and Municipal Employees / SCOAF-SUOAF - State College/University Organization of Administrative Faculty Includes a selection of correspondence, contracts, chapter documents, reports and publications dating from 1974-1997.

Sub-series III – CSEA - Connecticut State Employees Association / CEUI - Connecticut Employees Union Independent / CSFT - Connecticut State Federation of Teachers Includes correspondence, contract information, early by-laws, CSEA chapter meeting minutes, reports and publications which document some of the earliest collective bargaining activity on campus. These records date from 1959-1983.

Sub-series IV – A & R - Administrative and Residual Employees Union Offers correspondence, contracts, publications and reports dating from 1993-present. Some early A&R contract information is also available in: CSEA-CEUI/Contracts/ Master Contract for 1 July 1971.
